

#### Law

For any legal job, you need to be careful, logical and accurate. You should have a good memory and be able to think quickly.

As of May 2025 there was 14,900 legal professionals in Scotland, down from 16,800 in March 2024<sup>1</sup>, including over 700 accredited paralegals. <sup>2</sup> The Scottish Courts and Tribunal Service employs around 1,900 people across 50 locations in Scotland in roles that support the legal system, including court officers and administrative assistants and officers. <sup>3</sup>

#### What areas can I work in?

Sectors in this career area include professional law, legal support services and patent work.

There is a range of jobs at different levels, from administrative posts such as court officer, through to professional roles such as solicitor or patent attorney.

Law degrees are also suitable for employment in other career areas, for example business management.

# What kind of companies can I work for?

Companies you may work for include:

- legal firms
- the Scottish Court Service
- the Civil Service
- local government
- Crown Office and Procurator Fiscal Service (COPFS)
- Faculty of Advocates
- public bodies, such as the Citizens' Advice Bureau.

### What's the job market like?

According to Prospects and AGCAS, 53.4% of law graduates from the academic year 2021/22 went on to full time employment within 15 months of graduating. 45.5% of those found employment in legal, social or welfare roles. Of those graduating, 9.4% went on to further study. A further 15.4% continued to study whilst working. <sup>4</sup>

The Law Society of Scotland currently has over 13,000 members. <sup>5</sup> The number of trainee solicitors in Scotland as of 31 October 2024 was 764 and in 2023 there were 759 newly admitted solicitors, an increase from 622 in 2022. <sup>5</sup>

#### **Facts and figures**

The Chartered Institute of Patent Attorneys (CIPA) represent the interests of over 4,600 practising patent attorneys and other intellectual property professionals. <sup>6</sup>





As of 2023, 58% of practising solicitors were female. <sup>5</sup>

As of the end of March 2024, the Crown Office and Procurator Fiscal Service (COPFS) employed 2,373 full time staff. They also had 59 trainee solicitors and 42 Modern Apprentices. <sup>7</sup>

There were 60,943 civil law cases initiated across the Court of Session and Sheriff Courts in 2022-23. This represents an increase of 13% from 2021-22. 8
